The regular monthly meeting of the Governmental Ethics Commission was called to order at 1:03 p.m. by Chair Hale.

Minutes

John Solbach

Commissioners reviewed the minutes from the July 22, 2020 meeting. Ms. Deterding moved to approve the minutes as written. Mr. Krull seconded the motion. The motion carried unanimously.

Executive Director Report

Mr. Skoglund reviewed budget information. The agency is funded by the state general fund, (taxpayer dollars) and fees form lobbyist, candidate, and PAC registrations as well as penalties and fines. Two Legislative sessions ago, the agency was concerned with the decade long trend where the portion of the budget of the Ethics Commission funded by the state general fund had steadily reduced, causing repeated agency cuts and increased pressure on the fee fund. In the 2019 session the Legislature agreed with the concern and increased the portion of the agency budget that came from the general fund with the intent that this would last through FY21. In the 2020 session the Legislature also approved to moving our staff attorney to a full-time position. The agency budget for FY21 is \$734,424, of which \$470,000, approximately 64%, comes from the state general fund. Of the agency budget, over 75% is for staff salaries. The investigator is contracted, and those wages are from a different fund. Our budget is not discretionary. After the budget bill is signed, in situations where the state general fund can be problematic, the Governor can issue allotments. Agency budget cuts which happen after the budget process has concluded. Allotments were issued to 18 state agencies, Governmental Ethics being one. The amount of our allotment is \$20,756 which is a substantial amount for our small agency to absorb. A plan to address the allotment had been addressed in seven budget categories: deferred salary increase, deferred computer replacements, eliminated data entry temporary assistance, office supplies, stationery, postage, and printing. The services the agency provides will not be reduced because of these cuts. Mr. Skoglund had three considerations for changes to the 20-21 budget submission. The first being transferring the amount that was cut from the state general fund for FY21 and FY22 to the fee fund. On a short-term basis, confident that the fee fund has a balance that could sustain this; however, not something to maintain in the long run. Second, change the fee fund to unlimited,

currently the budget bill includes a specific amount that can be utilized each year from the fee fund. This agency conducts investigation and the costs can be unpredictable. As a result, it would be best if the fee fund was a no limit fund. Mr. Skoglund stated that he will continue to look for ways to adhere to the salary plan.

Mr. Skoglund requested that the Commission appoint a sub-committee to approve the budget as the due date was September 15, 2020. The Commissioners volunteering for the sub-committee were Mr. Hellmer, Ms. Deterding and Ms. Dengler.

Mr. Skoglund reviewed the statistics for the July 27, 2020 Receipts & Expenditures Report for state candidates, county candidates, Parties and Political Action Committees. The statistics included the total number required to file; number which filed an affidavit of exception, reports filed in a timely manner and the number of failure to file notices sent for each entity. Mr. Skoglund presented the statistics on the number of people required to file a Statement of Substantial Interest, the total received to date and those not yet filed. Noting the circumstances this year making submittal more difficult and He noted that the total number of 81 shown on the chart as not received had dropped to 68 after printing of the information for the Commission.

Civil Penalty Waiver request

Mr. Skoglund presented the letter submitted by Brian Burch, lobbyist for Catholic Vote Civic Action. Discussion ensued. The Commission took no action on the waiver request.

Paid for by Attribution Statements Waiver requests

Before reviewing the documents submitted by candidates regarding the lack of paid for by attribution statements, Mr. Skoglund stated that typically the Commission would waive the first offense, including a strongly worded letter to the candidate, unless there are extenuating circumstances that would lead the Commission not to waive.

Stacy Nielson, Candidate for Edwards County Register of Deeds submitted an email regarding the newspaper ad and Facebook page which lacked the paid for by attribution. She assured the Commission that all future ads would have the required statement of attribution and she corrected the Facebook page.

Mike Brown, candidate for Johnson County Commission, had a GoFundMe page which lacked the attribution statement. Mr. Skoglund saw the page on a neighborhood social media networking site. Mr. Skoglund contacted Mr. Brown, who immediately corrected the error.

Mr. Krull moved that the first-time offenses be waived, a letter be sent, and a copy be placed in each file. Mr. Solbach seconded the motion. There was no discussion. The motion passed with Ms. Deterding voting no.

Chair Hale stated the next agenda item is the executive session, the time being 1:22p.m.

Mr. Skoglund interjected that there was a respondent who had joined the meeting. As the Executive session would a lengthy one, there was little that could be accomplished in 8 minutes.

As Mr. Ramirez was available and if he did not object to beginning 7 minutes early, the public hearings could begin.

Public Hearings

Complaint No. 684

The Public Hearing on Complaint No. 684, Mark Skoglund vs. Christian Ramirez was called to order at 1:23 p.m. by Hearing Officer Mr. Solbach. The hearing was recorded. Mr. Solbach asked if there was a consent agreement. Mr. Skoglund responded that there was none. Mr. Berry confirmed there was no consent decree, but Mr. Ramirez had submitted a request for consideration at the last meeting (executive session). Mr. Solbach reviewed the hearing procedures and asked Mr. Berry to state appearances for the record.

Mr. Berry stated that he appears on behalf of Commission Director Mark Skoglund, the Complainant, who also appears. The Respondent appears in person, remotely per Zoom (videoconference) as all the meeting participants appear, and he appears pro se. There are no other appearances. Mr. Solbach directed Mr. Berry to give his opening statement. Mr. Berry asked the Hearing Officer to inquire if Mr. Ramirez disputes the fact that his report was not timely filed, by February 2, 2020. Mr. Solbach asked Mr. Ramirez if he would like to respond. Mr. Ramirez stated that he did not dispute that point. Mr. Solbach asked if Mr. Berry wanted to make an opening statement. Mr. Berry submitted that based upon the Respondent not contesting the fact that the report was not filed by the deadline of February 2, 2020 that there would probably not be a need for presentation of evidence. That there would be an opportunity for the parties to comment on what they would like to see for a disposition. Mr. Solbach asked Mr. Berry to proceed with his recommendation for the disposition. Mr. Berry stated that he had an opportunity to confer with Mr. Skoglund, the Executive Director, and there was no specific recommendation for the Commission. Mr. Solbach asked Mr. Skoglund for his recommendation. Mr. Skoglund stated his recommendation was solely to remind the Commission that normally once the report is filed, we typically dismiss these violations as the report was filed; however in this instance, there had been three previous violations as treasurer of a PAC. Mr. Skoglund did not have a specific recommendation. A small amount is sufficient so the individual would take the deadlines seriously.

Mr. Solbach asked Mr. Ramirez if he wished to address the Commission.

Mr. Ramirez said that he was a first-time candidate and elected official and there were a number of items to deal with right after taking office and to learn many things in a very small time span. By the end of March, he knew he had to file the report, but in his best judgment the safety and prosperity of his district had to be the priority and deal with first.

Mr. Solbach asked Mr. Ramirez if he had a recommendation for a fine. Mr. Ramirez stated that he had no recommendation. Discussion ensued.

Ms. James made a motion that a fine of \$750 be assessed and paid within 60 days. Mr. Hellmer seconded the motion. There was no additional discussion. The motion passed unanimously.

Mr. Solbach stated that the matter would be referred to the Attorney General or the District Attorney as is appropriate and required to do, with a recommendation that no criminal action be taken. Mr. Solbach stated as there was nothing further in this matter, this hearing is now closed. (1:38)

Mr. Skoglund stated that there were three more public hearings. As attempts at contacting Troy Smith had not been successful, he recommends that the Troy Smith hearing be continued rather than hold in absentia.

Complaint No. 685

Ms. Solbach stated that he had been appointed as hearing officer in the Complaint No. 685 Mark Skoglund vs Brandie Armstrong. He asked if Ms. Armstrong was present. Ms. Armstrong replied that she was in attendance. Mr. Solbach stated that the Executive Director had offered to make a statement. Mr. Skoglund noted that Ms. Armstrong was treasurer for Mr. Ramirez. She had no priors and had not been late on reports previously. The report in issue has been filed. Mr. Berry recommended that someone on the Commission make the motion to dismiss the complaint, as the report had been filed and Ms. Armstrong had no previous violations.

Mr. Hellmer, based on the recommendation of the Director and Counsel of the Commission, moved that the Commission find sufficiency and dismiss. Ms. Dengler seconded the motion. There was no further discussion. The motion carried with Ms. Deterding voting no. Mr. Solbach stated that there was nothing further in this matter and the hearing in this matter is now closed.

Ms. James asked Ms. Armstrong if she had any questions. Ms. Armstrong asked if there was anything more for her to do. Mr. Solbach said there was not.

Complaint No. 683

The Public Hearing on Complaint No. 683, Mark Skoglund vs. Sarde Douthard was called to order at 1:47 p.m. by Hearing Officer Mr. Solbach. The hearing was recorded. Mr. Solbach reviewed the hearing procedures and asked Mr. Berry to state appearances for the record.

Mr. Berry stated that Executive Director Mark Skoglund appears, with counsel Brett Berry on behalf of the Commission. The Respondent, Sarde Douthard appears pro se, personally by Zoom teleconference. Mr. Solbach asked if Ms. Douthard wanted to make an opening statement now or wait until after the Complainant's counsel made an opening statement and presented evidence. Ms. Southard stated that she wanted to wait.

Mr. Berry called Jennifer Schneider, Local Level Campaign Finance Coordinator, present online through Zoom. Ms. Schneider was placed under oath by Judge Hellmer. Ms. Schneider responded to questions from Mr. Berry. Ms. Douthard said she had no questions for the witness. Judge Hellmer swore in Ms. Douthard.

Ms. Douthard stated that she was not aware that there was a report due January 2020. The campaign had ended March 2019, two months after, she had no contact with the candidate.

Ms. Douthard explained this being her first campaign, she was learning quickly and did not know all the information or responsibilities as the treasurer, and if she could file with what she had, she would.

Mr. Hellmer, made a motion that based upon the evidence presented by the Counsel for the Commission, the preponderance of the evidence had proven the complaint, and therefore should enter a finding that Ms. Douthard was in violation. Ms. Deterding seconded the motion. There was no further discussion. The motion passed unanimously. Discussion ensued.

Mr. Moore made a motion that the Commission assess a \$250 fine which would be waived in its entirety if the Respondent cooperated with Commission staff to the extent possible in 30 days and recommended that no further action be taken. Ms. James seconded the motion. Discussion ensued. The motion passed unanimously.

Mr. Hellmer recommended that Ms. Douthard complete the report as best she can and resign to protect herself.

Mr. Solbach stated that there was nothing further in this matter and the hearing in this matter is now closed. (2:18p.m.)

At 2:19 p.m., Mr. Krull made a motion that the Commission recess this open meeting until 3:00 pm, for executive session to discuss matters limited to confidential complaints with staff present to participate in the discussions, pursuant to K.S.A. 75-4319(b)(1), (b)(2), and K.A.R. 19-6-2.

Mr. Moore seconded the motion which passed unanimously.

The Commission returned to open session at 2:45 p.m.

Next meeting date

Chair Hale noted the next meeting would be September 23, 2020. Mr. Skoglund stated should circumstances arise that require the Commission meet in person arrangements have been made; however, most likely the meeting would be by Zoom.

Mr. Berry asked if there were people in attendance (for the meeting) at the Governmental Ethics Office. Office manager Fergel confirmed neither Mr. Smith nor any members of the public were present.

Adjournment

At 2:48 p.m. Mr. Moore moved to adjourn the meeting. Ms. James seconded the motion. There was no additional discussion and the motion carried unanimously.

A. Salaries and Wages:

Salaries and Wages decreases by \$1,473 below the amount approved by the 2020 Legislature. This reduction is attributable to the following changes:

Increases:

- ~\$1,400 Base and fringe benefit correction related to a salary raise
- \$576 Adjustments to fringe benefits, largely due to health insurance adjustments

Reductions:

- -\$3,682 Temporarily delaying salary raises per Governor's Allotment Plan
- Adjustments related to budgeting for Commissioner meeting stipends (this change does not impact amounts received by Commissioners)

B. Contractual Services:

Contractual Services decreases by \$13,930 below the amount approved by the 2020 Legislature. This reduction is attributable to the following several changes:

Increases:

- \$2,000 Court reporter fees, in anticipation of hearings that may require these services
- \$1,776 Westlaw corrected improperly low billing rate and this category is properly reflected in the budget
- \$418 Adjustment in state mandated fee required for any agency with office in Shawnee County
- \$400 Projected increased load for in-office copier

Reductions:

- -\$13,644 Altered IT billing structure results in a significant reduction.
- -\$3,000 Did not hire temporary data entry assistance to ensure budget stability after the Governor's Allotment Plan
- -\$1,206 COGEL conference is virtual and not charging registration fee
- -\$507 Janitorial building cost adjustment
- -\$175 COGEL membership fee adjustment

C. Commodities:

Commodities is unchanged from the amount approved by the 2020 Legislature.

D. Capital Outlay:

Capital Outlay decreases by \$1,710 below the amount approved by the 2020 Legislature. This reduction is due to computer replacements being reclassified by the state IT service as a contractual service rather than capital outlay (-\$2,035), offset slightly by adding expenditures for office furniture (\$325).

A. Salaries and Wages:

Salaries and Wages increases by \$9,235 above the budget request for FY 2021. This increase is attributable to the following changes:

Increases:

- \$3,682 Temporarily delayed salary increases in FY 2021 that are not delayed in FY 2022
- \$2,529 Expiration of the Governor's moratorium regarding KPERS Death and Disability
- Fringe benefit increases (\$843 KPERS, \$2,158 health insurance)

B. Contractual Services:

Contractual Services decreases by \$2,857 below the budget request for FY 2021. This reduction is attributable to the following changes:

Increases:

- \$2,718 Anticipated adjustment in IT expenses
- \$2,000 Printing in preparation for FY 2023 state election cycle
- \$1,437 Rent adjustment
- \$926 COGEL conference attendance
- \$704 Computer replacements
- \$429 Adjustment in state mandated fee required for any agency with office in Shawnee County
- \$200 Janitorial contract adjustment
- \$29 Mileage rate projection

Reductions:

- -\$10,500 Postage costs during non-state election year

C. Commodities:

Commodities is unchanged from the budget request for FY 2021.

D. Capital Outlay:

Capital Outlay increases by \$75 above the budget request for FY 2021. The increase is attributable to furniture replacement.

A. Salaries and Wages:

Salaries and Wages increases by \$2,775 above the budget request for FY 2022. This increase is attributable to fringe benefits adjustments in group health insurance, offset slightly by decreases in KPERS benefits.

B. Contractual Services:

Contractual Services increases by \$9,038 above the budget request for FY 2022. This increase is attributable to the following changes:

<u>Increases:</u>

- \$6,500 Postage costs during statewide election year
- \$3,000 Data entry temporary assistance
- \$1,292 Building rent adjustment
- \$638 Computer replacements
- \$353 Adjustment in state mandated fee required for any agency with office in Shawnee County
- \$231 Mileage rate projection

Reductions:

• -\$3,000 – Printing costs during election year

C. Commodities:

Commodities is unchanged from the budget request for FY 2022.

D. Capital Outlay:

Capital Outlay is unchanged from the budget request for FY 2022.



^{*}The Ethics Commission budget traditionally does not budget planning to receive fines and penalties due to variance and perception of actions taken by the Commission, though of course these values will not be zero in reality.

Budgeted years (FY 2021-FY 2023) are higher than actual expenditures out of necessity, since budgets set maximum expenditures. This contributes to what appears to be a reducing ending balance in the fee fund.

Below is a chart comparing the total Ethics Commission budget (blue bars) to the proportion of that budget that comes from the state general fund (orange line). The Legislature and the Director worked together in the 2018 legislative session to obtain a larger percentage of the budget from the state general fund. FY 2021-FY2023 lines represent the budget request, while FY 2010-FY 2020 represents actual expenses.



V. Reduced Resource Package

For FY 2022, the Governor has required the Ethics Commission and any other agency funded with the state general fund to prepare a reduced resource package amounting to a 10.0% reduction in funding from that source. This reduction option is included parallel to the budget submission as a choice the Governor and Legislature makes during the budget process.

The Ethics Commission budget does not include a significant amount of discretionary expenses, which limits options for preparing a reduced resource package. However, below details the package prepared by the Director, with notes regarding impact:

Additionally, reductions in postage expenses has a multiplier effect, as it would reduce the ability to seek payment owed to the agency for assessed fines and penalties.
Printing	\$11,000	-\$5,000	Printing costs would be significantly below actual printing expenditures for the agency at any point in the last decade. The agency would not print reports, instructional guides, or statute books. The agency predicts this would result in an increase in violations of the ethics, lobbying, and campaign finance laws.
Commission Meeting Costs	\$7,447	-\$3,000	The Commission would be required to cancel meetings and hold others virtually. Some Commission business is statutorily required to occur in person, delaying investigations.
Computer Replacements	\$2,464	-\$2,464	All computer replacements would be delayed to FY 2023. The Commission has several computers that are already out of warranty and experiencing difficulties in functionality.
Court Reporter	\$1,000	-\$1,000	Elimination of court reporter costs may result in increased costs to the agency in future years, as transcripts of recordings and appeals are likely to be more expensive and more difficult to defend without a court reporter present for more complicated hearings.
Miscellaneous	n/a	-\$2,700	This category includes copier expenses, office supplies, computer supplies, computer equipment, and office furniture.
Fee Fund Coverage		+\$26,875	See below.

The identified substantial reductions in the few discretionary categories in the agency budget result in a decrease of \$18,164. The Reduced Resource Package requires a state general fund reduction of \$45,039. The remaining \$26,875 presents two options for the agency. Either the contracted investigator position is eliminated or the agency fee fund would increase by \$26,875 to cover the outstanding amount. Eliminating the investigator position would have substantial impacts on the agency's ability to enforce the laws under its jurisdiction and therefore is not included in the reduced resource package.

In response to agency concerns regarding projected balances in the Governmental Ethics Commission Fee Fund as a result of decreased state general funding over time, the 2018 Legislature provided an increased proportion of the agency budget from the state general fund to begin in FY 2021, intending for the budget share to continue in future years. I strenuously oppose the use of Commission fee funds for any purpose aside from actions in support of the Ethics Commission's central mission.


CIVIL PENALTY ASSESSMENT ORDER
